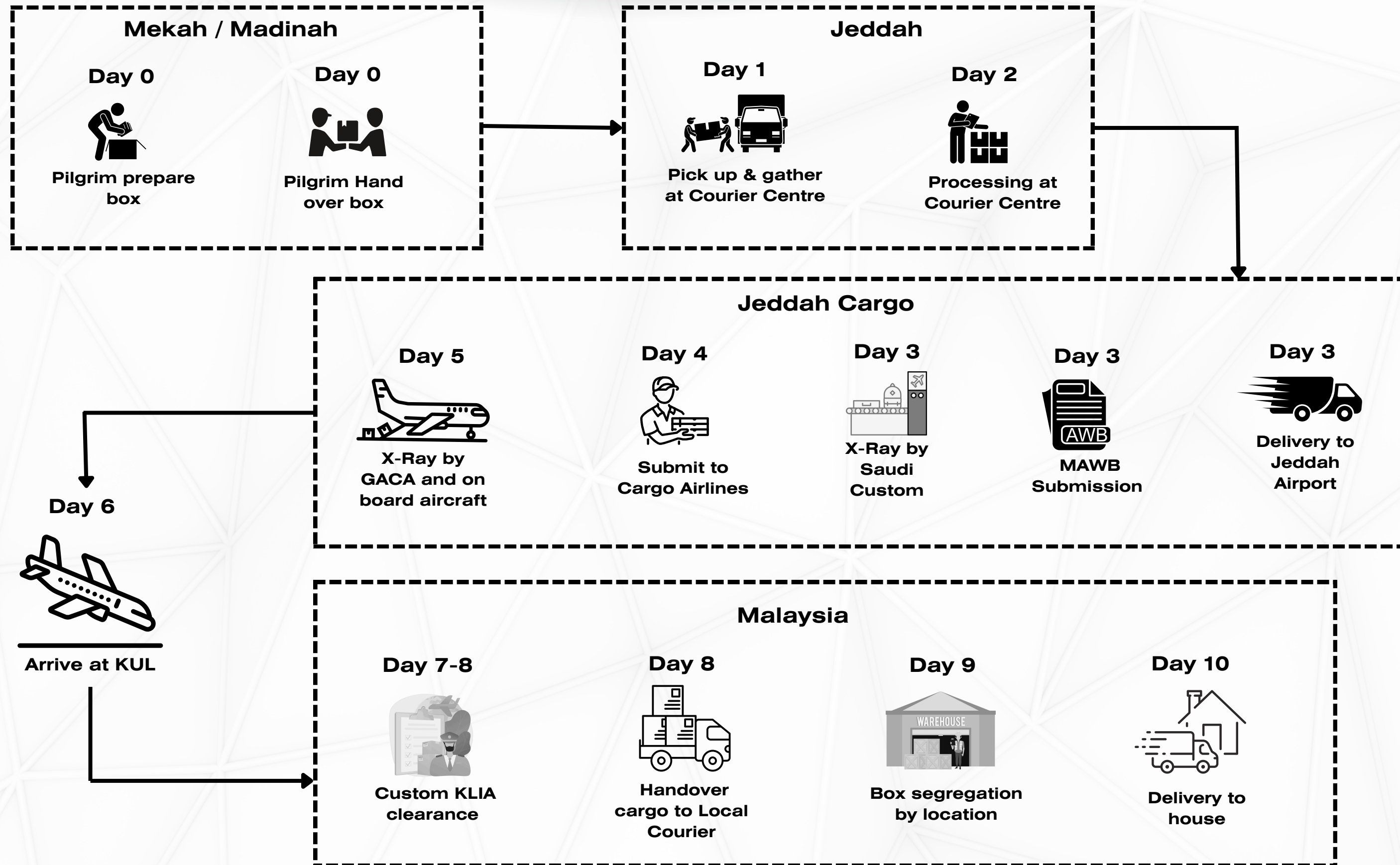

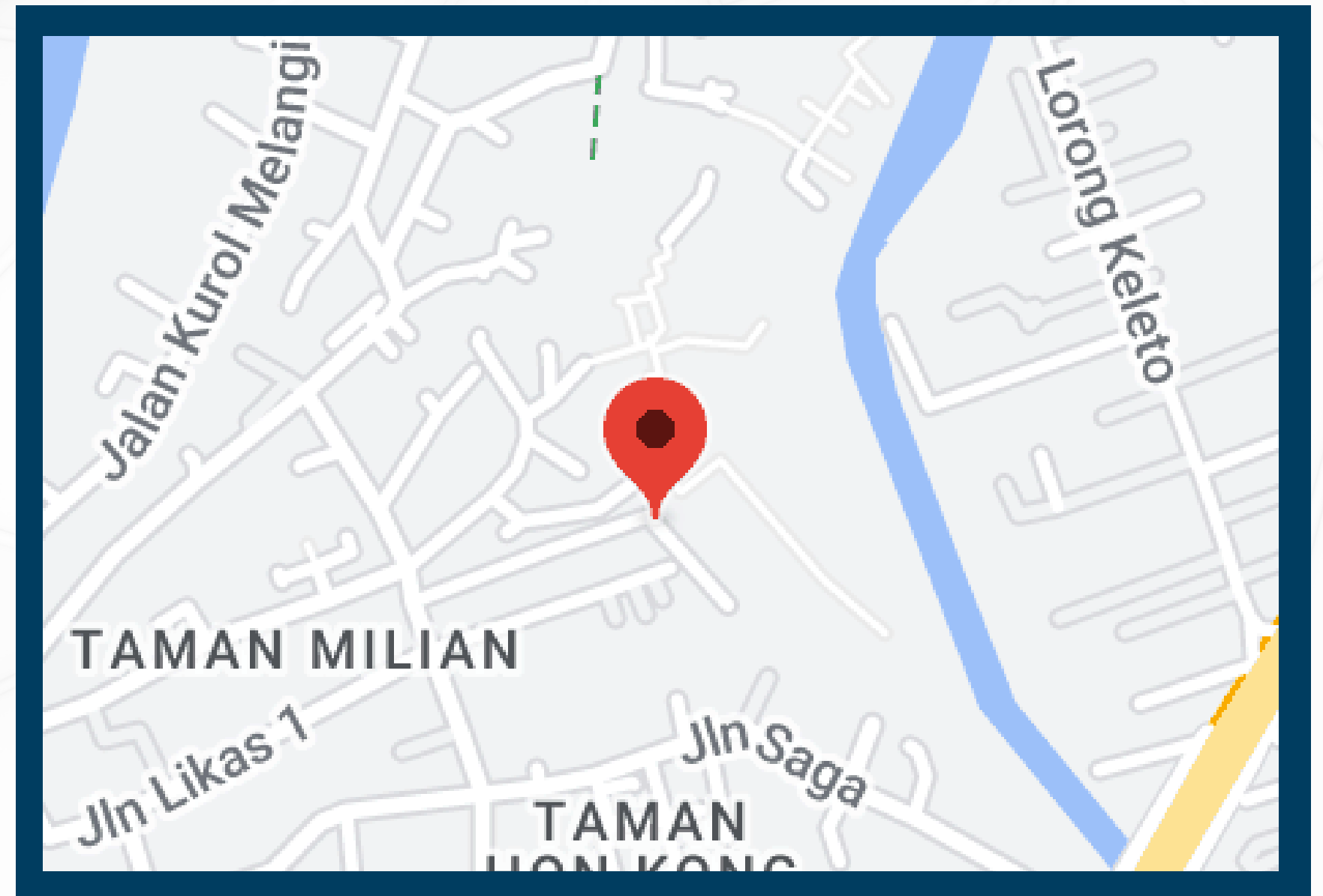
OFFICE LOCATION (HQ)
